Fighting For Family Caregivers & Their Loved Ones

The Credit For Caring Act Waits For Congress

Most family caregivers spend roughly **20 hours per week** looking after ailing family members. The trouble is that these dedicated caregivers don't receive appropriate compensation for their tireless contribution. This could change with the introduction of **The Credit For Caring Act** to the U.S. Senate.

The Elder care community is urging Congress to pass a **Federal Tax Credit that will provide between \$2,000-\$3,000 annually to qualifying family caregivers.**

According to AARP, about **40 million family caregivers across the U.S. provide 37 billion hours of unpaid care.** Family caregivers are estimated to save taxpayers **\$470 billion of "free" care a year.** Additionally, this aid helps their loved ones live happier, and more independently in their communities.

Not only does this incredible contribution of aid to loved ones by these family caregivers **save taxpayers billions,** but their efforts can prevent delays for other less-fortunate members of the community from receiving nursing home, and hospital care.

78% of family caregivers who take care of their aging loved ones **pay out of pocket** to ensure that their family members are getting the necessary care. On average, family caregivers pay \$7,000 annually to take care of their ailing family

NEW Durable Power of Attorney Law in Georgia!

On July 1st, the Georgia Uniform Power of Attorney Act went into effect!

Although the new statutory form, along with the new Georgia code (law), is much better than the one previous , it *does not* specifically include protections for seniors who are aging and want to take measures to protect their assets in the event they could qualify for government assistance programs, like Veterans Benefits or Medicaid. In order to completely protect yourself, your new power of attorney must include certain “**Special Instructions.**” Thus, a “standard” form, even on the new statutory form, will *not* be enough for most seniors who care about protecting their families and their assets.

MEDICARE & TRAVEL THINGS TO CONSIDER

Keep in mind the following 3 pieces of information about your Medicare insurance coverage before you hit the open road:

- Original Medicare and Medicare Supplemental (MediGap) Plans are valid and *must* be accepted across the country by **any provider** who accepts Medicare insurance
- Medicare Supplemental plans are available to cover medical care required during overseas travel
- Medicare Advantage (Part C) Plans work with select providers – make sure to **notify your Medicare Advantage provider** within 24 to 48 hours if you receive *emergency out of network* care while traveling
